

WAIVER AND ASSUMPTION OF RISK

I, _____, (please print name) hereby release Mark “Wolf” Johnson, Rocky Mountain Wildlife Foundation Incorporation (a 502C3 Corporation), Bill Betz, and Vanessa Hess from any and all liabilities of any nature whatsoever should I become injured or damaged by any animal or activity at the Rocky Mountain Wildlife Foundation Sanctuary in Guffey, Colorado, 80820.

By entering onto the premises at the Rocky Mountain Wildlife Foundation Sanctuary located in Guffey, Colorado, 80820, I hereby knowingly and voluntarily, and after having been informed of the risk inherent, I assume all risk of damages, injury, harm and death and waive any and all rights to sue individually or in a representative capacity as a result of my assumption of all risk.

I realize that all animals at Rocky Mountain Wildlife Foundation Sanctuary have been vaccinated against rabies and are free from any communicable diseases to humans. I also realize that the animals at the sanctuary may not be considered domestic, and that injuries could result from scratches by their claws or nips by their teeth.

I have been advised about how to handle the animals at the Rocky Mountain Wildlife Foundation Sanctuary, and I have been warned not to insert my fingers inside the chain-link enclosures, because an accidental bite could occur. I have also been warned not to corner any of the animals, and to allow the animals to approach me at their own free will. To approach and corner any Rocky Mountain Wildlife Foundation Sanctuary animal could result in an attack, since any canine may be dangerous if cornered. I also realize that the sanctuary is located on uneven terrain, and that I am to wear hiking boots or solid shoes to avoid injury on the mountain slopes.

I do not hold Mark “Wolf” Johnson, Rocky Mountain Wildlife Foundation, Bill Betz, or Vanessa Hess responsible for any injury obtained while hiking on the property or in the animal enclosures, either by stepping in a hole or other uneven terrain, tripping on the chain link enclosure itself, or if I am knocked down by one of the Rocky Mountain Wildlife Foundation Sanctuary animals.

The foregoing statements are not exhaustive of the information given to me about the risk of my entering upon the property located at the Wolf Rocky Mountain Wildlife Foundation Sanctuary, Guffey, Colorado, 80820.

I am visiting the Rocky Mountain Wildlife Foundation Sanctuary to learn about wolves and wolf hybrids, their behavior, how to properly handle an exotic animal, and/or volunteer my time or services to the Sanctuary. No lawsuits will be filed against Mark “Wolf” Johnson, Rocky Mountain Wildlife Foundation Sanctuary, Bill Betz, or Vanessa Hess for any accidental injuries.
